SUPERINTENDENT AWARDS:

ACTION:

- Appointed Mark Penrod as school board member to represent Zone 5 of the district.

- Adopted the following school board policies: BFD/BFE/BFG, Board Policy Implementation JECB, Admission of Nonresident Students and AR JECF, Inter-District Transfer of Resident Students and AR
- Approved Johnny Nicholson as Varsity Baseball Coach contingent upon enough eligible players to make a team.
- Approved Revised School Calendar to reflect final make-up day due to inclement weather in February. All teaching staff will work Friday, April 18. - Approved advancing second-year probationary status: Jan Colley and Kari DeKalb (who are eligible for third-year probationary) over to two-year contract status for 2014-2016.
- Approved rolling two-year contracts for contract teaching staff as submitted.
- Approved advancing second-year probationary administrator, Amanda O'Brien, to a three-year administrator contract for 2014-2017.
- Approved a new three-year administrator contract, 2014-2017, for Jon Zwemke.
- Approved a second-year probationary contract for Sarah Ches.
